Local Transport Plan

Murray Woodburn (Traffic & Transport Manager) introduced the 2024 MKCC Local Transport Plan (Local Transport Plan 5).

The Local Transport Plan in a strategic overview for transport and the network undertaken by transport authorities.

Milton Keynes City Council is preparing its 5th LTP which will look at plans for the next 10-15 years, tying in with core strategies such as MK Futures 2050 and the new City Plan. The LTP will look at how the network and transport in all modes might grow and change as the City does over this period.

The LTP will sit over other transport strategies and policies such as the Local Cycling and Walking Plan (LCWIP) and the Bus Service Improvement Plan (BSIP).

 Murray is keen to work with WSTC and other groups to arrange a residents meeting in the new year to introduce the plan and the consultation process and to receive initial feedback on the major priorities for Woburn Sands and its surrounds.



Bletcham Way Extension - H10 into SEMK Urban Expansion

As you may be aware the Church Farm development has a valid planning consent to construct an access road from the current H10 Bletcham Way which is only suitable for this development but is unsuitable to accommodate any future developments beyond the Church Farm site.

MKCC (Milton Keynes City Councils) wish to proceed with the construction of the H10 Bletcham Way Extension to cater for future developments. The detailed design is being carried out by consultant with MKCC Major Projects managing the works which will be carried out by our approved Service Contractor.

The works will start from 02 Jan 24 and should be by completed by end of April 2024, weather permitting.

The project has been divided into 2 phases:

Phase 1 – Construction of a Temporary access road to permit early works to start on the development and facilitate the construction of the main road under Phase 2. Works will include:

- Removing some trees / foliage
- Installing Bat Boxes
- Reconstructing parts of Gregories Drive and Byrd Crescent
- Ground Investigation works.
- Construction of a temporary road

Phase 2 – Construction of the main Eastern extension of H10 grid road which includes a new bridge over Byrd Crescent and a new enlarged roundabout.

• Details of the full H10 Works, programme, road closures/diversions etc. will be sent nearer the date of the works.

Thoughtful attention has been given to minimise disruption to residents and business, we apologise in advance for any inconvenience whilst we carry out these advance highway works.

We will be coordinating these works with our Streetworks team to minimise disruption to road users. There will be a full (24 hour) road closure in place during this time to create a safe working space whilst we carry out the work.

A diversion route for road users / cyclist / Bridlepath users will be clearly signed and access for emergency vehicles will be maintained. Local Buse route will also be on diversion for some part of the works. We will notify residents, businesses, local school, and parish councils in advance through our usual channels (a copy of the Information Letter is attached).

Extension of Bletcham Way – Cabinet Decision

Following on from the Delegated Decision of 25 January 2022, the Council in conjunction with the relevant developer, has advanced the work to design the first phase of the extension of the H10 grid road, which will take the H10 into the Church Farm development, and towards the South East Milton Keynes Strategic Urban Extension (SEMK).

Prior to moving to a final position on the design works and delivery programme, which will be detailed in a further Decision to be made in the New Year, works to complete the design and facilitate the delivery phase are required to be carried out over the winter and require further funding at this stage.

Permission is sought at this stage to release additional funding from the Tariff Programme to finance the works required to facilitate the completion of the H10 extension design work, particularly the design of the bridge structure providing grade separation over Byrd Crescent, and the advance works required to allow for the delivery of the extended H10, works which are expected to commence, subject to the required approvals, in the second half of 2024

..... It's a standard GI Plan – looking at existing situation and opportunities under access, landscape, biodiversity and historic environment headings. I'm still drafting, so don't have something shareable quite yet. It's not quite the 'norm' for a GI Plan, in that almost all of the entire parish is GI, so opportunities are needing to be looked at differently - at the moment it is a bit more 'inward looking' than others. We have engaged with WSTC – Cllr Peter Skelton came to our first workshop, and Cllr Sarah Mills the second – and I will be sending something through to Sarah about GI Plan methodology etc shortly.

I've attached a GI Plan from elsewhere for information on the type of product. (* attached)

In terms of climate change initiatives, Cllr Susan Clinch (who sits on the GC Board) would be a good person to ask, as she is also Ampthill Climate Change Group (susan.clinch@centralbedfordshire.gov.uk) who have created wildflower meadows on verges and amenity land (and do a lot more).

Stephen Mooring (<u>stephen.mooring@centralbedfordshire.gov.uk</u>) is the lead officer.

South Beds Friends of the Earth are the other active local group – contact is another CBC elected member (Victoria.harvey@centralbedfordshire.gov.uk)

I've also copied Daniel in as he may be aware of more from the GC climate change theme.

As for Bedford Borough, although I've done a fair bit of work with them on Local Plan Policy (including Environmental Net Gain) and Local Nature recovery. I would suggest Stephen Mooring would know of counterpart teams/activities.

From Daniel at Greensand Trust - I would agree with all of the leads that Jon has provided in terms of climate change initiatives. I would also add the community energy projects, of which five individual groups have been identified across Central Beds. The Ampthill based group is the most advanced, but not too far behind is a group based in Leighton Buzzard. Their central coordinator is Kelly Dibbert kelly.dibbert@communityenergysouth.org

Leaf Fall Collection - Currently, the Authority have been

prioritising leaf fall using their management hierarchy. The first is clearing leaves in critical

catchment areas - so these are areas known to the Authority that if leaves are not clear they may block some gullies which could lead to flooding both temporary flash flooding and longer-term residual water retention. These are now complete.

We are now moving onto CMK and the main high street areas. We are currently in CMK and working in these locations and then onto High Streets. From there we will work with locations identified through Parishes and other key locations.

We anticipate getting to this location within the next 10 - 12 working days.

Yellow Lines

From 1 January 2024 we will changing how we accept requests for double yellow lines.

Each year the highways team receive a large number of requests for double yellow lines for various areas of Milton Keynes, mostly to sort out parking issues.

Before double yellow lines may be installed, a Traffic Regulation Order (TRO) must be in place so that any enforcement may take place. A TRO can only be created and implemented after a legal process has been completed. The legal process to create a TRO can take several months including formal and informal consultation periods.

This takes up a lot of resource including cost and staff time, and some proposals do not move past the informal consultation stage due to a lack of community support for a scheme.

This is why we are changing the process and to give local parishes and ward councillors more involvement with these requests.

The guidance and new process are attached.

This will be circulated to town, parish and community councils in early December.

Any existing requests will be dealt with through this new process.

New ways of working to deliver street cleansing and empty public bins

The chemical spraying is provided by the landscape sub-contractor Glendale. The list provided as part of the street cleansing briefing was not exhaustive and included activities up to a certain date. I highlighted areas (but perhaps not all) in Danesborough & Walton ward and the following feedback has been provided.

Below are the treatment dates for the areas you listed. I have checked with the spraying teams and they have confirmed Eagle Farm, Glebe farm and Walton were not treated as they did not appear on our programme. When these areas are adopted they will need to be added to the mapping and weed spraying programme. I inspected some of the areas yesterday and can see that the chemical has started taking effect on the weeds but has not yet died off. This could be due to the current weather conditions (cold temperatures and fewer daylight hours slows the translocation of the chem from the leaves to the roots) and these sites were completed at the end of the programme in mid Oct to early Nov.

A second spray is due in the spring (we only benefited from a single annual spray under the previous contract terms) and the warmer weather and longer light conditions should increase the efficacy of the chemical and speed up the process of the weed dying back. It will no doubt take a few cycles coupled with better mechanical sweeping to see the improvements expected across the city.

Support for the Open University's Campus 2030 Project

Milton Keynes City Council is set to formally support the Open University's Campus 2030 project, through which it is exploring the opportunity to relocate to Central Milton Keynes, alongside the potential for providing in-person courses for students.

The city council's Cabinet gave its support for the project when it met on 7 November.

Creating a large city centre undergraduate university has been a long-held ambition for Milton Keynes, giving local school leavers an opportunity for higher education close to home, as well as attracting other talented young people to the city. Opening a university typically brings significant economic benefits, as well as enhancing an area's leisure and culture.

Earlier this year, the Open University began developing a business case that considers, among other options, a move of the OU's campus to Central Milton Keynes from its current base in Walton Hall. This business case will be put to its University Council in July 2024.

Milton Keynes Development Partnership (MKDP), the company owned by the city council to develop MKDP land assets, is working closely with the Open University to facilitate the business case development.

To consider supporting the Open University's Campus 2030 project and the benefits it would bring to the City and Milton Keynes Development Partnership's continued role in the project.

Council Size Survey

Most inclusive International Festival yet

MKCC support IF: the MK International Festival, which happens every other July, to help keep events free or low cost for local people. It's part of the objectives for the city to have an inclusive economy and be a centre of creativity.

The organisers have just announced that around 56,000 people went to this year's IF performances, with around 180,000 more experiencing free public events as they passed by.

83% of the programme was free to attend, which is really positive compared to major festivals in other cities.



A campaign which aims to help women and girls feel safe in Milton Keynes, is being promoted by the city council.

The White Ribbon campaign encourages people, especially men and boys, to challenge behaviour and change the culture that leads to abuse and violence against women.

To support the move, the council, which became White Ribbon Accredited last year, offers a range of supportive domestic and sexual abuse policies, guidance and training for colleagues, along with housing and support services for women and children who need to flee violence and abuse.

It also has a range of measures to improve safety on the streets and in schools for women and girls, and is setting up a network of male 'ambassadors' and female 'champions' among employees and councillors, to promote the message and raise awareness.

Using £750k of Home Office funding secured by the city council and its Safer MK partners, upgrades have been made to the city centre to give women more confidence they can be safe at night, including lighting and reflective paint in underpasses along popular pedestrian routes to increase visibility, CCTV, and cutting back bushes and shrubs at entry and exit routes.

MILTON KEYNES RESIDENTS REMINDED TO STAY SAFE AROUND FROZEN WATER THIS WINTER



As colder weather begins to set in, city residents are reminded to stay safe in Milton Keynes' parks this winter.

Glistening frosts and the occasional dusting of snow may look beautiful, but it's vital to stay vigilant around cold or frozen water.

When ice forms on open water, it can put people and pets at risk, so The Parks Trust is reminding residents to take care near lakes, canals, ponds and rivers.

The Parks Trust has issued its top tips for staying safe:

Keep away from the water's edge and under no circumstances go onto the ice or enter the water. Be extra watchful with young children close to the water's edge.

If you see someone in trouble in the water or on the ice, call 999 straight away. Never attempt to go out on to the ice yourself.

Be cautious after heavy rainfall and don't enter areas that are flooded.

Keep your dog under control near frozen water and NEVER follow it onto the ice. Do not attempt to rescue any pets yourself – call the emergency services for help.

If you see a wild animal you believe to be in distress on the ice, report it to the RSPCA on 0300 123 4999.

To help young minds become aware of the potential dangers, The Parks Trust, the charity caring for over 6,000 acres of Milton Keynes' parkland, are providing free Water Safety Assemblies for MK schools.

Closure of YiS (Young Peoples Mental Health)

It is with a heavy heart that we announce the closure of YiS effective from 31 December 2023. This follows a Resolution agreed upon at an All Members Meeting.

The decision comes from significant funding challenges that have placed an unprecedented strain on the Charity.

Despite our best efforts, the current financial landscape has proven challenging, leading us to the difficult realisation that we can no longer sustain our mission. We understand this decision's impact on individuals who have relied on our services.

Launch of MK New City Plan Online Engagement

Tell us about your neighbourhood, asks city council

Milton Keynes City Council is asking local people to share their thoughts and experiences of how they use their local neighbourhood to help shape its New City Plan.

The New City Plan is an important planning document which will describe the environment needed to deliver the city council's 'Strategy for 2050'. The Strategy, which was finalised two years ago following extensive public consultation, sets out a bold and ambitious vision for Milton Keynes including equal opportunities, new jobs, affordable and 'lifelong' homes that suit people at all stages of their life, and a pioneering mass rapid transit system.

To help develop the New City Plan, Milton Keynes City Council will be holding a series of specialist workshops and groups over the next year, as well as running surveys around specific themes. This week, the city council has published a survey asking people about how they use their local neighbourhood, such as whether they find it easy to shop, take children to school, and enjoy green space; what changes would improve their mental and physical health; and what would make them more likely to use local facilities. It runs until 23 February next year. Click to take part.

It's also asking for feedback on an early draft of what's called a 'design code' for Milton Keynes. Design codes are used by planners to set standards for how communities should be designed,

thinking about what makes a place attractive, distinctive, and high quality. This consultation closes on 19 January next year. Click to take part.

A previous survey asking for views on how Milton Keynes may be impacted by climate change, and how the city council could address this, closes shortly on 28 November. Click to take part.

Leader of Milton Keynes City Council, Cllr Pete Marland said: "Our ambitious Strategy for 2050 is a vision for high-quality sustainable growth, genuinely affordable housing, and new job opportunities for the next generation. Creating a New City Plan is an important step in making these ambitions a reality. We're asking local people to share their thoughts and experiences to make sure the plan is grounded in what people love or would like to change about Milton Keynes, so we can work with experts to best determine what will be needed by tomorrow's residents, businesses, and visitors."


