Although under the Town and Country Planning (Determination of Appeals by Appointed Persons) (Prescribed Classes) Regulations 1997, the appeal was to have been decided by an Inspector, the Secretary of State considers that he should determine it himself.

Accordingly, in exercise of his powers under section 79 and paragraph 3 of Schedule 6 of the Town and Country Planning Act 1990, the Secretary of State hereby directs that he shall determine this appeal instead of an Inspector. This means that instead of writing a decision, the Inspector will prepare a report and recommendation, which will be forwarded to the Secretary of State.

The reason for this direction is that the appeal involves proposals for residential development of over 150 units or on sites of over 5 hectares, which would significantly impact on the Government's objective to secure a better balance between housing demand and supply and create high quality, sustainable, mixed and inclusive communities.

This direction is being served on the Inspector (if appointed), the appellant (or their representative) and the local planning authority.

Following its approval at the Milton Keynes Council meeting on 18 October, I am writing to give you advance notice of the publication of the Proposed Submission version of Plan:MK (the new strategic development plan for the Borough) for public consultation. This is the version of the plan which the Council intends to submit to the Government in spring 2018 for independent examination.

The consultation period during which you may submit comments on the plan will be from 8 November until no later than 5.00pm on 20 December.

The plan and its main supporting documents are already available on our website here. The technical studies and evidence which supports the plan are available here. These documents will be added to between now and 8 November.

The policies maps which identify the site-specific allocations included in the plan and any existing policy designations which are proposed to be changed are available here.

The consultation at this stage of the plan's preparation will focus on whether the plan has been prepared in accordance with legal and procedural requirements and whether it is 'sound'. Government planning policy states that a sound local plan is one that is:

- Positively prepared the plan should be prepared based on a strategy which seeks to meet objectively assessed development and infrastructure requirements, including unmet requirements from neighbouring authorities where it is reasonable to do so and consistent with achieving sustainable development;
- Justified the plan should be the most appropriate strategy, when considered against the reasonable alternatives, based on proportionate evidence;

- Effective the plan should be deliverable over its period and based on effective joint working on cross-boundary strategic priorities; and
- Consistent with national policy the plan should enable the delivery of sustainable development in accordance with the policies in the National Planning Policy Framework.

Formal notification of the consultation will be sent to everyone on our consultation database on or shortly before 8 November. All comments which are submitted by 20 December will be considered not by Milton Keynes Council but by the independent Planning Inspector appointed to examine the plan.

As part of the consultation process, we shall staff an exhibition on Plan:MK in the Central Library in Central Milton Keynes from 7-10 November. This exhibition could be made available (unstaffed) to other libraries or venues in the Borough. We are also open to attending your parish meetings to explain the proposals in Plan:MK.

Please let us know if you wish to suggest any additional venues for the exhibition or to request our attendance at a parish council meeting. We shall do our best to accommodate any requests.

Oxford – MK – Cambridge Expressway

Recent response from National Infrastructure Commission

"Thank you for your email to the Department for Business, Energy and Industrial Strategy, in relation to the proposed Oxford to Cambridge Expressway. It has been transferred to the Department for Transport and I have been asked to reply.

As you know we are currently conducting a strategic study into developing an expressway between Oxford and Cambridge to improve east-west connectivity within the region and support future housing requirements. I have provided a link to the most recent report on the strategic study, which you may find useful in providing you with more details on the potential corridor options along with reasoning behind the study.

The study is still in its early stages, and we are currently examining three potential broad corridors: corridor A, the southernmost option, corridor B, the central option and corridor C the northernmost option. Both Highways England and the Department for Transport are working together to examine these options and engaging with local stakeholders on a regular basis. We also note that the National Infrastructure Commission has been doing work in this area, and will take interest in their findings.

I thank you for raising your concerns, and will ensure that they are fed back into the decision making process. However I would like to stress that the study into the Expressway is still at a very early stage and we are yet to identify a preferred high level corridor, let alone route.

The expressway is likely to be considered as a nationally significant infrastructure project under the Planning Act 2008. There are well defined requirements under this regime, which include an examination by inspectors appointed by the Planning Inspectorate. I can also assure you that the project will follow the standard Highways England development approach, which does include a public consultation in addition to other technical work. This means that both yourself and others in your community will get the opportunity to express their views during the development process."



Capital of Culture Bid

Milton Keynes submitted its bid to become European Capital of Culture 2023. The bid is called **Different by Design** and if successful, Milton Keynes will be the first ever European new town to be

designated as a European Capital of Culture. The competition recognises places that aspire to and have a plan for greater cultural development and transformation, rather than to reward places that are already known as being culturally rich.

A send-off was held by the leader of the council; Pete Marland, the European Capital of Culture steering group chair Ann Limb and other MK representatives at Station Square. Two Milton Keynes 2023 branded electric cars, called Sid and Elsie, were driven to London to deliver the Different by Design bid books to the Department for Digital, Culture, Media and Sport. Milton Keynes' title and concept is Different by Design, which explores how the city is completely different in concept and design to any other city in the UK.

It tells a different story about British culture, not one steeped in Victoriana, ancient monuments, high art and tradition, but one about Britain when it thinks about the future. It highlights the unexpected Milton Keynes, asking people to look again at a place they may think they know, but don't. Judges will be asked to consider the variety and vibrancy of Milton Keynes' communities and our green landscape, which includes millions of trees.

Finally it commits to a grass roots plan to embed culture into the very fabric of the city, creating a year-long celebration that is shaped and curated by the people of Milton Keynes. Milton Keynes has a bid budget of £150k for the first stage application. Leeds, Nottingham, Dundee and jointly Belfast and Derry also submitted bids for the title of European Capital of Culture 2023. The shortlist will be announced at the end of the year.
